Administrative Disqualification Hearing (ADH) Yog Dabtsi?

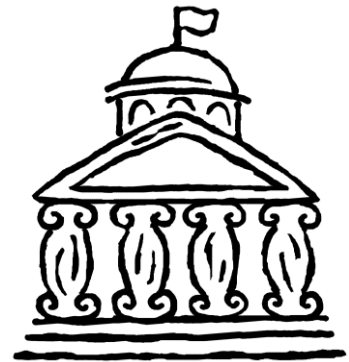
Txhais tau hais tias dag los sis zais tau cov kev pab tsoom fwv. Yog hais tias lub County xav koj tau ua li no, lawv sau tau ntawv mus raug txim them nyiaj, thiab tej zaum yuav tuav ib “administrative disqualification” rooj sib hais (ADH). Ib qho ADH yog ib lub rooj sib hais kom txiaiv txim siab yog tias koj cog lus civil dag kom tau MFIP, DWP, zov menyuam, General Assistance (GA), Group hnoog Housing (GRH), Minnesota Supplemental Aid (MSA), Medical Assistance, MinnesotaCare, SNAP thiab Emergency Assistance (EA).

Yuav ua li cas rau lub nras yuav tsum tau los ua pov thawj?

Nyob rau hauv ib qho kev ADH, lub county yuav tsum qhia kom meej thiab convincing pov thawj ntawm kev dag. Qhov no txhais tau tias lawv muaj qhia hais tias koj tau ua los yog hais ib yam dab tsi nyob rau lub hom phiaj kom tau ib yam dab tsi los ntawm lub county uas koj yuav tsum tsis tau tau.

Yuav ua li cas yog hais tias tus ADH Kws txiaiv txim plaub pom kuv ua yuav kev thiab tsis yog?

Koj poob koj cov kev pab rau 1 lub xyoo rau ib tug ua txhaum thawj zaug, 2 xyoos rau ib tug ua txhaum zaum ob thiab mus tas li rau ib tug ua txhaum zaum peb. Yog hais tias koj tsis tsim nyog tau los ntawm MFIP, koj kuj poob cov zaub mov kev them nyiaj yug (SNAP). Koj yuav tsis tau kaw lub sij hawm nyob rau hauv ib qho kev ADH, tab sis txhua yam uas koj hais los yog dab tsi rau lub nras pom tawm nyob rau hauv ib qho kev ADH yuav siv tau tawm tsam koj yog hais tias lawv sau ib daim ntawv raug txim them nyiaj.



Kuv yuav tsum tau zam lub rooj sib hais?

Lub county yuav hais kom koj kos npe rau ib daim ntawv kom zam lub rooj sib hais. **Hu hais plaub pab dawb rau tswv yim ua ntej koj kos npe rau!** Yog hais tias koj kos npe rau nws, koj muab koj txoj cai mus hais plaub. Koj kuj poob koj cov kev pab txawm tias koj tsis lees mus ua dab tsi rau lub nras hais tias koj tau ua. Yog hais tias koj kos npe rau daim ntawv no, koj muaj 30 hnub los hloov koj lub siab thiaj li hu hais plaub pab dawb yog tias koj muaj lus nug.

Muaj peev xwm lawv tseem ua ntaub ntawv raug txim tsub?

Tau. Lub county yuav coj ob qho tib si ib tug ADH thiab raug txim tsub rau koj. Txhua yam uas koj qhia rau lub county yuav siv tau tawm tsam koj tom qab. Yog hais tias koj ua ib nqe lus los yog kos npe rau ib daim ntawv, tej zaum koj yuav tsum muab koj txoj cai mus siv lub 5 Amendment yav tom ntej, nyob rau hauv ib tug raug txim mus sib hais. Lub 5 Amendment yog koj txoj cai kom tsis txhob ua tim khawv tawm tsam koj tus kheej nyob rau hauv ib tug criminal case. Koj yuav tsum tham nrog ib tug kws lij choj kom tau cov lus qhia ntxiv txog qhov no.

Yuav ua li cas yog hais tias kuv thov ib daim ntawv ceeb toom uas yuav tau txiav los yog txo tau kuv cov nyiaj?

Rov hais dua hais tias yuav ua ke nrog lub ADH dag hais plaub. Tau raws li txoj cai kev pab tam sim ntawd. Lub rooj sib hais yuav tricky, vim li cas rau lub nras muaj los ua pov thawj yog txawv rau txiav koj cov kev pab tshaj rau kev dag. Lub county tsuas yog xav tau los ua pov thawj hais tias feem ntau ntawm cov lus tseeb uas nyob rau nws cov sab mus txiav tawm los yog txo koj cov kev pab. Tiam sis lawv yuav tsum tau meej thiab convincing ntawv pov thawj rau kev dag.

Yuav ua li cas yog hais tias lawv ua ntaub ntawv raug txim tsub?

Tom qab ntawd koj yuav tsum hais kom lawv poob los yog ncuu lub rooj sib hais ADH.

Yog tias kuv txhaum ntawm txhaum kev dag los sis yog tias kuv nyob rau hauv ib tug kev ua si kev pab cuam?

Yog hais tias koj pom txhaum ntawm coj tsis ncaj kom tau welfare, koj yuav poob koj cov kev pab. Koj tseem yuav tau kaw lub sij hawm los yog nplua. Koj poob koj cov kev pab rau 1 lub xyoo rau ib tug ua txhaum thawj zaug, 2 xyoos rau ib tug ua txhaum zaum ob thiab mus tas li rau ib tug ua txhaum zaum peb. Tej yam ntxiv ua txhaum txhais tau tas disqualification. Qhov no muaj tseeb txawm hais tias koj nyob hauv ib tug kev ua si kev kawm los yog lub tsev hais plaub txib kom nyob thiab nyob txim.



Yuav ua li cas yog hais tias kuv tsis yog ib tug xeem xaj US?

Yog hais tias koj tsis yog ib tug pej xeem US, tham nrog ib tug kws lij choj sai li sai tau. Qhov saum toj no teeb meem cuam tshuam rau koj tuaj txawv teb chaws.
