Criminal Records

### Dabtsi nyob hauv kuv qhov Keeb kwm kev txhaum cai?

Cov Keeb kwm kev txhaum cai hauv lub xeev Minnesota yeej muaj cov ntaub ntawv qhia txog tag nrho txhua yam koj raug ntes, tsub cov txim, thiab cov txim txhaum. Saib peb daim ntawv qhia, [Cov ntaub ntawv pub peixeem pom piv Cov ntaub ntawv tsis pub peixeem pom: Keem Kwm kev Txhaum Cai.](#)

### Vim li cas cov ntaub ntawv raug ntes ho yuav tsum muab qhia tawm?

Txoj cai lij choj hauv lub xeev hais tias cov koom haum ntawm tub ceev xwm hauv lub xeev yuav tsum tau qhia tawm txog cov kev raug ntes es kev txhaum yog lub txim felony thiab gross misdemeanor rau cov tub ntxhais hluas thiab neeg laus. Lawv yuav tsum tau qhia tawm txog lub hom phiaj ntes cov neeg laus rau cov txim hu “targeted misdemeanor.”



**Sau cia:** Qhov kev txhaum hu ua “targeted misdemeanor” yog:

- tsav tsheb thaum qaug cawv
- lub txim ntaus neeg fifth-degree assault
- txij nkawm sib ntaus hauv tsev
- cuam tshuam qhov tsis pub lwm tus paub
- liab qab rau neeg pom
- yuam qhov tsev hais plaub daim ntawv tsis pub tsis tiv tauj, muaj ntawv tiv thaiv, muaj ntawv tsis pub thab ze, los yog ntawv tiv thaiv kom tsis txhob raug mob los ntawm lwm tus.

Cov kev raug ntes no yuav tsum tau muab qhia mus rau lub chaw Bureau of Criminal Apprehension (BCA). Lub chaw BCA ceev tag nrho cov keeb kwm ua txhaum cai hauv lub xeev Minnesota.

### Yam dabtsis thiaj li tsis muab qhia tawm?

Tsis yog tag nrho cov kev raug ntes ntawm lub txim txhaum me hu ua misdemeanor yuav tsum tau muab qhia tawm rau tim BCA, tabsis cov chaw ua hauj lwm ntawm cov tub ceev xwm hauv lub zos yeej qhia tau yog tias lawv xav qhia.

Feem ntau ntawm cov txim txhaum me hu ua misdemeanor es tsis muab qhia tawm yog:

- coj tus cwj pwm tsis raws cai
- tus sab lub txim misdemeanor thiab
- yuam cov kev cai tsav tsheb uas tsis yog qaug dej cawj/yeeb tshuaj

## Kuv cov keeb kwm txhaum cai muab ceev rau qhov twg?

Koj cov keeb kwm txhaum cai muab ceev ntawm cov tsev hais plaub, lub chaw BCA, thiab lwm lub koom haum tub ceev xwm li cov tsev tub ceev xwm ua hauj lwm hauv zos. Tej thaum cov keeb kwm no muab khaws koj los ceev cia ntawm tej lub tuam txhab tsis yog tsoomfwv.

## Nrhiav Tau Lawv li Cas

Koj tshawb fawb siv lub npe lossis lwm cov ntaub ntawv qhia txog lawv. Lub MCRO cov ntaub ntawv cia koj mus saib daim ntawv hu uas “Register of Actions.” Daim ntawv yuav qhia lub ntsiab lus txog txhua yam tshwm sim ntawm koj rooj plaub nyob hauv tsev hais plaub.

Koj mus tshawb fawb tau txhua rooj plaub ua txhaum txim lossis raug kaw uas nyob hauv tsev hais plaub, tshwj yog muaj tshem/lwv tawm lossis tseem hais tsis tau tiav. Koj nrhiav tau cov rooj plaub tseem hais tsis tau tiav, tiamsis koj yuav tsum paub rooj plaub tus naj npawb, daim pib tus naj npawb, tus kws lijchoj lub npe, lossis tus kws lijchoj tus naj npawb muaj cai hais plaub. Ib rooj plaub tseem hais tsis tau tiav uas raug tso tseg lawm lossis tseem tos yuav raug tso tseg. Koj tshawb fawb tsis tau cov keebkwm raug ntes uas tsis raug foob lossis mus tom tsev hais plaub.

- Koj muaj feem mus tshawb fawb tagrho ntawm txhua lub “computer” hauv Minnesota cov tsev hais plaub rau cov pejxeem. Qhov ntawd yog rau cov raug tso tseg lawm thiab tseem hais tsis tau tiav. Mus tom ib lub tsev hais plaub thiab nug ib tug neeg ua haujlwm “court clerk” kom luam ib daim ntawv uas muaj cov rooj plaub txhaum txim thiab raug kaw. Feem ntau, cov tsev hais plaub yuav ib tug nqi luam ntaub ntawv \$8.00 mus rau \$10.00. **Koj tsis tas yuav luam txhua daim keebkwm.**
- BCA’s lub vassab <https://dps.mn.gov/divisions/bca/bca-divisions/criminal-justice-information-services/background-checks/public> muaj cov keebkwm ntawm cov rooj plaub uas raug txiav txim txhaum lossis kaw thiab uas koj lub txim txhaum raug tshem tawm li ntawm 15 xyoo tas los. Mus muab kom tau koj daim ntawv keebkwm hauv BCA, nrog rau cov ntaub ntawv uas raug ntes tabsis tsis txhaum, koj yuav tau mus thov tshwm ntsej tshwm muag lossis xav ntawv mus. (mus saib “Kuv mus nqa ib daim ntawv txog kuv qhov keebkwm raug txim tom BCA li cas?”)
- Koj cov keeb kwm es muaj nyob hauv cov tuam txhab tsis yog tsoomfwv kuj muaj nyob hauv online nyob ntawm tuam txhab twg. Koj yuav tsum tau mus kuaj nrog lawv.

Yog hais tias koj nrhiav cov keev kwm ntawm ib rooj plaub tshwm sim ntawm lwm lub xeev, tiv tauj lub tsev hais plaub uas rooj plaub ntawm tshwm sim.

## **Ua li qhov keeb kwm ntawm qhov kev txhaum cai los ntawm BCA puas muaj tag nrho kuv cov ntaub ntawv qhia txog kuv cov kev txhaum cai?**

Qhov keeb kwm ntawm qhov kev txhaum cai nyob ntawm BCA muaj cov ntaub ntawv qhia los ntawm tub ceev xwm, cov tsev hais plaub, thiab cov chaw kaw neeg los ntawm lub xeev tag nrho.

Tab sis, yog tias qhov ua txhaum ho tsis muaj cov ntiv tes dov rau hauv ntaub ntawv ce ev cia, cov ntaub ntawv es muaj feem xyuam txog qhov kev txhaum ntawd yuav tsis yog ib feem ntawm qhov keeb kwm nyob hauv BCA txawm tias koj txhaum lub txim.



## **Kuv yuav ua li cas thiaj tau ib daim luam tag nrho kuv cov keeb kwm txhaum cai los ntawm BCA?**

Koj yeej nug tau kom luam koj cov keeb kwm txhaum cai los ntawm BCA. Cov ntawv luam tawm no muaj cov ntaub ntawv pej xee m pom thiab cov ntaub ntawv es tsis pub pej xee m pom. Koj yeej muab tau koj cov keeb kwm hauv BCA kom lawv xa tuaj los yog mus nqa tim ntsej tim muag.

**Xav hauv pais xav nis tuaj:** Sau tiav ib [daim ntawv nug](#) (*lus Askiv xwb*). Muab daim ntawv no los ntawm BCA los yog siv daim es muaj nyob nrog daim ntawv qhia ntawm no. Sau kom tiav tag nrho thiab kom muaj lub thwj ntaus rau.

Koj tsis tas siv daim ntawv no los tau. Koj cia li sau tau ib daim ntawv mus nug kom luam koj ib daim keeb kwm xa tuaj. Nws tseem yuav tsum tau muaj lub thwj ntaus rau. Saib zoo kom daim ntawv muaj koj lub npe thiab hnub yug, thiab lwm lub npe koj keev siv.

Xai daim ntawv es koj ua tiav los yog daim ntawv es koj sau mus nrog rau ib daim tshev los yog “money order” es yog \$8.00 thiab sau them rau BCA. Yuav tsum kom muaj ib lub hnab ntawv muaj koj lub chaw nyob thiam muaj daim stamp lo rau kom lawv paub xa rov qab rau koj.

**Mus nqa tim ntsej tim muag:** Koj yeej mus tau ntawm lub chaw ua hauj lwm hauv BCA thiab nug kom luam koj cov keeb kwm rau koj. **Lub chaw BCA yuav kom koj dov ntiv tes.** Koj yuav tsum tau them \$8.00. Koj yuav tsum tau muab koj daim npav I.D. rau lawv saib, xws li daim npav tsav tsheb.

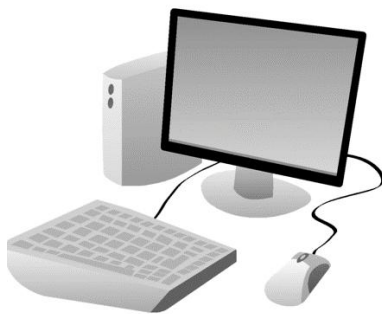
## **Yuav ua li cas yog kuv xav tias cov keeb kwm nyob hauv BCA yuam kev los yog muaj tej yam ntaub ntawv qhia tsis muaj nyob rau hauv?**

Yog hais tias koj tsis pom zoo txog cov ntaub ntawv qhia nyob hauv BCA, koj muaj cai tawm tsam cov ntaub ntawv ntawd. Koj yuav tsum tau piav qhia tias qhov keeb kwm twg yog cov es koj xav tias yuam kev lawm los yog muaj tsis txhij.

### **Kuv puas ua tau li cas rau kuv cov keeb kwm kev txhaum cai es tawm hauv lwm qhov chaw online?**

Muaj ib co tuam txhab uas khwv nyiaj los muab neeg keeb kwm txhaum cai yais tawm hauv online. Cov tuam txhab tej thaum hu ua “aggregators” vas sab los koom haum sau lus txog koj. Ib tug “aggregators” qhov dej num ib nyuag txawv ntawm qhov lawv txoj kev tshem tawm koj cov ntaub ntawv txog koj. Yog hais tias koj pom cov keeb kwm nyob hauv online es yuam kev, tij tauj ncaj qha mus rau tus “aggregator” vas sab los koom haum sau lus txog koj.

## Kuv tshem puas tau tej yam nyob hauv kuv cov keeb kwm kev txhaum cai?

Qee zaus. Nws hu ua Expungement. “Tshem tawm” yog thaum koj mus hauv tsev hais plaub mus nug tus kws txiav txim plaub kom muab cov keeb kwm kaw tsis pub neeg pom. Mus muab tau qhov Expungement yuav pab tau koj yog tias koj muaj teeb meem nrhiav hauj lwm, nrhiav tsev nyob, los yog kom ib daim ntawv tso cai “professional license” vim yog koj muaj cov keeb kwm kev txhaum cai.

Ib qho keeb kwm es raug expunged yuav TSIS MUAB rhuav tshem. Cov tub ceev xwm, FBI, cov neeg ua hauj lwm tswj teb chaws, thiab lwm cov neeg hauj lwm rau tsoom fwv yeej tseem pom tau cov ntawv lub tsev hais plaub muab kaw cia rau hauv tsev hais plaub vim muaj lwm yam.
