Daim ntawv qhia no pab puas tau kuv?

Yog hais tias koj tau koj daim xam xaj U.S. thiab koj yog ib leej niam thiab txiv, koj cov menyuam es tseem tsis tau yog xam xaj kuj rais los ua tau xam xaj **nyob ntawm tej rooj plaub**. Qhov no yog tau xam xaj los ntawm qhov hu ua “muab tau los” xam xaj. TABSIS koj yeej tseem kom muaj cov ntaub ntawv xws li daim ntawv pov thawj ntawm daim xam xaj os yog phau ntawv hla teb chaws, kom muaj POV THAWJ tias koj tus menyuam yeej yog ib tug neeg muaj xam xaj. Daim ntawv qhia tseeb no qhia kom koj paub tias txoj hau kev mus muab kom tau cov ntaub ntawv no.

Daim ntawv qhia tseeb no tsis qhia cov ntaub ntawv txog cov txheej txheem mus muab kom tau cov ntaub ntawv ua pov thawj qhia koj cov menyuam yog xam xaj yug hauv teb chaws U.S., cov menyuam yug txawv teb chaws es yog yug los ntawv cov niam txiv yog xam xaj U.S., los yog cov menyuam es coj los tu los ntawm cov niam txiv es yog xam xaj U.S.

Daim ntawv qhia qhov tseeb no tham txog cov ntaub ntawv thov nrhiav tau hauv internet. Yog hais tias koj tsis muaj ib lub computer, koj kuj siv tau cov computer hauv lub tsev pej xeem qiv ntawv “public library”. Koj kuj hu tau lub khoos kas tau hais los no thiab nug lawv kom xa ib daim ntawv tuaj rau koj.

Thaum ib leej niam txiv rais los ua xam xaj lawm, puas yog tias cov menyuam cia li rais los ua xam xaj thiab?

Tus menyuam kuj ua tau ib tug xam xaj U.S. yog tias TAG NRHO cov hauv qab no yeej muaj, los yog twb tau muaj dua los, yeej tseeb tib yam nkaus thaum tib lub sij hawm:

1. Tus menyuam lub hnuv nyoog qis tshaj 18 xyoos.
2. Tus menyuam yog ib tug neeg nyob tau tas mus li hauv teb chaws U.S. (muaj daim npav ntsuab).
3. Ib tug ntawm ib leej niam los txiv yog ib tug neeg xam xaj yug hauv teb chaws U.S. los yog nws xeem tau daim xam xaj. Yog hais tias tus niam tus txiv ntawd yog leej txiv thab sis tsis tau sib yuav nrog tus niam sab tod, nrog tus kws lij choj immigration tham Vim hais tias tej zaum koj toobkas povthawj ntxiv.



4. Tus niam txiv es muaj xam xaj yog tus niam txiv es koom roj koom ntshav nrog tus menyuam los yog yeej coj menyuam no los tu ua nws tus raw txoj cai. Tus niam txiv ntsiab tsis txaus qhov muab tau los ua xam xaj. Nrog ib tug kws lij choj tham yog hais tias qhov ua xam xaj no yog rau tus menyuam es coj los tu vim hais tias nws yeej muaj ib co cai lij choj tshwj xeeb txog qhov no.
5. Tus niam txiv es muaj xam xaj sib faib tu tus menyuam los yog muaj cai tag nrho tu tus menyuam thiab kev txiav txim siab tib leeg nkaus rau tus menyuam thiab nyob rau hauv U.S.

Yog hais tias tej no yeej muaj tseeb, koj tus menyuam ces cia li tau daim ntawv xam xaj U.S. taus los ntawm feem coob. Txawm hais tias koj tus menyuam muaj tshaj 18 tamsis no lawm los, yog hais tias 5 qhov khoom muaj tseeb thaum lawv tseem tsis tau muaj 18, ces koj tus menyuam twm cia li ua tau xam xaj U.S. lawm. Tiamsis koj tseem toobkas mus nqa povthawj tias nws yog xam xaj. Koj kuj ua tau li nov yog mus nqa **daim ntawv xam xaj** los sis ib **phau ntawv hla teb chaws** los sis **daim npav hla teb chaws**.

Nco Ntsoov: Yog tias tus “menyuam” yug ua ntej lub Ob Hlis ntuj Tim 27, 1983, yuav muaj lwm txoj cai rau nws. Nrog ib tug kws lij choj immigration tham.

Kuv tus menyuam yog xam xaj. Cov ntaub ntawv twg yog cov kuv yuav tsum muab kom tau?

Nws yog ib lub tswv yim zoo mus ua kom tau phau ntawv hla teb chaws **thiab** ib daim ntawv pov thawj xam xaj rau koj tus menyuam. Qhov no yuav pab tiv thaiv koj tus menyuam kom txhob muaj teeb meem rau nws lub neej tom ntej no. Tabsis koj tsis tas yuav kom muaj ob qho tib si.

Ib **daim ntawv pov thawj xam xaj** los ntawm lus tuam tsev Department of Homeland Security mas yeej tsis muaj hnuv tas caij nyoog li. Nws yeej kav koj tus menyuam tag tiam neej. TABSIS nws yuav tsis pub koj tus menyuam mus txawv teb chaws nrog daim ntawv pov thawj no. Daim ntawv pov thawj no mas kim tshaj li phau ntawv hla teb chaws.

Yog hais tias koj khwv tau nyiaj tsawg, koj kuj ua tau daim ntawv thov kom zam tus nqi es koj thiaj li tsis tau them qhov nqi. Nws yog ib qho es nyuaj heev kom pom zoo zam qhov nqi no. Saib daim ntawv qhia tseeb [Zam Tus Nqi them ua Ntaub Ntawv Immigration.](#)



Tej zaum nws yuav siv sijhawm 2 xyoo los tshaj thiaj tau daim ntawv ua xam xaj. Nyob ntawm lub sijhawm qho txheej txheem ua ntaub ntawv. Koj mus xyuas qhov sijhawm tamsis no rau daim Form N-600 hauv U.S. Citizenship thiab Immigration Services vassab ntawm <https://egov.uscis.gov/processing-times/>.

Phau ntawv hla teb chaws los ntawm lub tuam tsev U.S. Department of State tuaj mas tas caij nyoog li 5 lub xyoos rau cov menyuam es lub hnuv nyoog qis tshaj 16 lub xyoos, thiab 10 xyoos rau txhua tus. Phau ntawv hla teb chaws yuav tsum tau rov qab ua dua kom ntxiv tau caij nyoog.

Phau ntawv hla teb chaws pheej yig dua daim ntawv pov thawj xam xaj. Koj yuav thov tsis tau kom zam tus nqi them rau phau ntawv hla teb chaws. Nws yuav siv sij hawm li 11 lub asthiv los luv dua thiaj tau txais phau ntawv hla teb chaws.

Koj tus menyuam yuav mus ncig tau teb chaws nrog phau ntawv hla teb chaws.

- Daim **npav** hla teb chaws “passport **card**” pub koj siv ncig teb chaws hauv U.S. saum daim av los yog hauv dej hiav txwv, *tabsis koj siv tsis tau ncig mus rau txawv teb chaws es yog ya nyooj hoom.*
- **Phau ntawv** hla teb chaws mas tsis txwv qhov koj ncig tau heev npaum li cas.

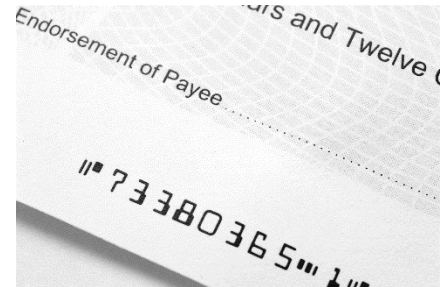
Ua ntawv thov Daim Ntawv Pov Thawj Xam Xaj (N-600)

Yog hais koj yog niam thiab txiv es muaj daim xam xaj U.S. rau ib tug menyuam es tsis tau muaj hnuv nyooj, koj yeej pab tau koj tus menyuam koj nws tau **daim ntawv pov thawj xam xaj**. Koj yuav tau mus sau daim ntawv N-600 hu uas Daim Ntawv thov Daim Ntawv Pov Thawj Xam Xaj. Yog koj tus menyuam dhau 18 xyoo lawm, lawv yuav tsum xee daim ntawv tus kheej.

Yog hais koj yog tus menyuam rau tus niam txiv yog U.S. xam xaj, koj kuj ua tau daim ntawv 600 no rau koj tus kheej.

Kuv yuav ua ntawv thov daim N-600 licas?

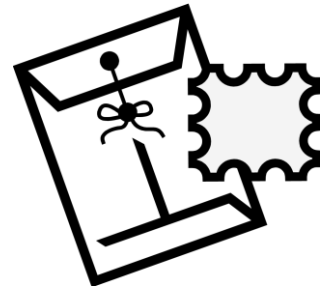
1. Mus muab daim ntawv Form N-660 online ntawm www.uscis.gov/n-600.
2. Sau daim ntawv kom tiav nrog cov ntaub ntawv qhia txog koj tus menyuam xws li qhov chaw yug nws, hnuv nyooj, seb nyob raw cai li cas hauv teb chaws, thiab lawv nyob qhov chaw twg, thiab qhia txog nws niam nws txiv.
3. Koj yuav tsum tau xa cov khoom no nrog daim ntawv ua mus thov:
 - Qhov nqi \$1,385 es yog sau tshev los yog tshev “money order” es sau rau U.S. Department of Homeland Security. Koj them tau siv ib daim credit card. Koj yuav tau siv daim ntawv Form G-1450 los ua qhov no. Daim ntawv no nyob ntawm <https://www.uscis.gov/g-1450>. Yog hais tias koj khwv nyiaj tau tsawg, ua ib daim ntawv thov zam qhov nqi no, Form I-912 Request for Fee Waiver. Koj kuj mus nrhiav tau daim ntawv no hauv www.uscis.gov/i-912 (*Ius Askiv xwb*). Yog hais tias pub zam rau koj, ces koj yeej tsis tau them ib qho nqi dabtsi li.
 - 2 daim duab nyuam qhuav thajj tsis ntev los no es yog hom duab rau phau ntawv hla teb chaws ntawm koj tus menyuam. Hom duab rau phau ntawv hla teb chaws mas yuav tsum zoo raws li qhov tau teev cia. Yuav tsum saib kom zoo es tus neeg thajj duab ntawv yuav tsum paub tias thajj zoo li cas. Yuav ua li cas yog hais tias kuv tsis muaj co ntaub ntawv yuav tsum muaj no rau daim ntawv thov N-600?

◆ **Yog hais tias koj tsis muaj koj tus menyuam daim npav ntsuab**, mus nug seb tej zaum ib lub hoobkas kuj yuav muaj ib daim qauv luam ceev tseg. Xws li tsev kawm ntawv, lub hoobkas pab nyiaj tsoom fwv, tus kws lij choj, los yog qhov chaw ua hauj lwm.

Yog hais tias koj tseem nrhiav tsis tau ib daim muab luam cia, koj tus menyuam kuj nug kom immigration luam nws cov ntaub ntawv rau nws. Ua kom tau cov ntaub ntawv no dawb mus thov hauv FOIA, daim ntawv Form G-639. Koj yeej ua tau daim ntawv thov FOIA no hauv online ntawm www.uscis.gov/g-639 (*Ius Askiv xwb*). Tej zaum ua siv li ob peb lim tiam lawv mas teb yog hais tias koj mus thov online. Tej zaum yuav siv sijhawm ob peb hli yog koj ua ntawv xa mus thov.

Koj kuj nug koj tau ib daim npav ntsuab tshiab los hloov daim qub. Koj ua tau li no yog koj ua daim ntawv thov Form I-90 Application to Replace Permanent Resident card Daim Ntawv Thov Ua IB Daim Npav Ntsuab Tshiab. Koj yuav tsum tau them tus nqi \$465 los yog ua daim ntawv thov zam tus nqi nov. Saib daim ntawv qhia tseeb [Hloov los yog Rov Ntxiv Sij Hawm rau Daim Npav Ntsuab \("Green Card"\)](#).

◆ **Yog hais tias koj muab tsis tau daim qauv es muab luam ntawm koj tus menyuam daim ntawv yug**, koj muaj feem nug kom tau 2 tug neeg es lawv nyog ntawd thaum lub sij hawm koj yug koj tus menyuam ib leeg sau ib daim ntawv lav tias nkawd yeej paub tseeb tias yeej yog koj tus menyuam "Affidavit of Birth."

Daim ntawv sau lav tias yeej paub tseeb yog koj tus menyuam (Affidavit of Birth) yuav tsum qhia kom mee txog tus neeg sau ntawd xws li nws lub npe, chaw nyob, xwm txheej nyob teb chaws no lwm yam. Lawv yuav tsum sau tus menyuam lub npe thaib niam txiv lub npe, tus menyuam lub hnuv yug thiab lawv ho paub tus menyuam no tau li cas thiab qhia txog paub thaum yug tus menyuam. Yog hais tias koj tsis muaj daim ntawv sib yuav, daim ntawv lav qhov tseeb no yuav tsum tau qhia tias seb tus niam txiv ntawd paus sib yuav thaum lub caij ntawd.

Daim ntawv lav qhov tseeb mas yuav tsum tau kos npe ntawm tus neeg "notary" ntaus twj pom.

◆ **Yog hais tias koj muab tsis tau daim qauv es koj luam ceev cia ntawm koj daim ntawv xam xaj** vim koj muab ua pawv lawm, koj kuj muab tau pov thawj los ntawm ua daim ntawv thov los ntawm daim ntawv thov FOIA ntawm koj cov ntaub ntawv hauv immigration (saib saum toj)



Los yog koj ua tau daim ntawv thov Form N-565, Application for Replacement Naturalization/Citizenship Document. Mus nrhiav daim ntawv no hauv www.uscis.gov/n-565 (*Ius Askiv xwb*). Koj yuav tsum tau them tus nqi \$555, los yog ua daim ntawv thov zam tus nqi nov, nug kom tau daim ntawv xam xaj tshiab.

Nco Ntsoov: Yog hais tias koj muaj 18 xyoos rov saum lawm thiab koj ua ntawv thov rau koj tus kheej thiab koj niam thiab koj txiv yog xam xaj tsis kam muab nkawd daim ntawv pov thawj xam xaj rau koj, hu ib tug kws lij choj. Ib tug kws lij choj kuj pab tau koj kom koj mus muab ib daim hauv tsev hais plaub.

Koj muaj feem mus ua daim ntawv thov Form N-600 txawm tias koj muab tsis tau daim npav ntsuab ntawm tus menyuam los yog koj daim ntawv pov thawj xam xaj. Lub tuam tsev The Department of Homeland Security yeej muaj cov ntaub ntawv no ceev cia hauv lawv cov ntaub ntawv. TABSIS lawv kuj yuav txiav txim tsis pom zoo rau koj daim ntawv thov yog koj tsis muaj cov ntaub ntawv no, yog li nco ntsoov yuav tsum tau xa cov ntaub ntawv no mus yog tias koj xa tau.

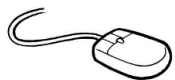

Koj tsis tas yog ib tug niam tus txiv xam xaj thiaj li ua tau ntaub ntawv thov kom tau phau ntawv hla teb chaws rau koj tus menyulam. Tabsis yog koj tsis yog xam xaj, koj tseem yuav tsum tau muaj cov ntaub ntawv ua pov thawj qhia txog tus niam txiv sab tod yog xam xaj. Qhov txheej txheem ua ntawv thov phau ntawv hla tej chaws thiab daim npav hla teb chaws ces zoo tib yam xwb. Qhov nqi mas txawv. Ib phau ntawv hla tej chaws rau cov menyulam es muaj hnub nyoog 16 xyoo kav li 5 xyoos. Yog koj muaj 16 xyoo thiab laus dua lawm koj phau ntawv hla teb chaws kav li 10 xyoo.

3. Sau daim ntawv no kom tiav qhia txoj koj tus menyuam xws li qhov chaw yug nws, hnuv nyoog, qhia txog niam thiab txiv, thiab chaw nyob.

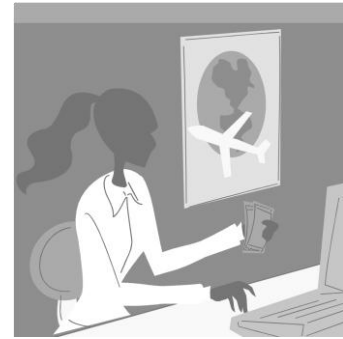
Nco Ntsoov: Yog hais tias tus menyuam twb yeej muaj daim ntawv xam xaj los ntawm qhov txheej txheem N-600, koj tsuas toobkas kom muaj daim ntawv ntawd rau kauj ruam no xwb.

- b. **Daim Npav Qhia Npe** rau ob leeg niam thiab txiv thiab ntawm tus menyuam yog yuav tsum muaj (saib hauv qab ntawm qhov “How does my child’s age affect the passport application?”). Daim I.D. yog tau li daim npav tsav tsheb, daim ntawv pov thawj xam xaj los yog lwm npav I.D. los ntawm tsoom fww.
- c. **Tus nqi them daim ntawv** (saib hauv qab ntawm “How does my child’s age affect the passport application?”)
- d. **1 daim duab thaij ua li phau ntawv hla teb chaws** ntawm koj tus menyuam. Hom duab li phau ntawv hla teb chaws mas yuav tsum kom zoo raws li qhov tau teev cia. Yuav tsum saib kom zoo tus neeg thaij duab ntawv yuav tsum paub tias thaij zoo li cas. Lub chaw USCIS lub vas sab www.uscis.gov (lus Askiv xwb) muaj ib kem qhia txog cov duab thaij ua phau ntawv hla teb chaws.

Kuv tus menyuam lub hnuv nyoog muaj kev cuam tshuam rau nws daim ntawv thov phau ntawv hla tej chaws li cas?

Cov menyuam es muaj 18 xyoo mus ua ntawv thov tau ntawm lawv tus kheej, es ua raws nraim li cov kauj ruam saum toj no. Lawv mus thov tau yog tias lawv tau lawv qhov kev xam xaj los ntawm lawv niam lawv txiv *ua ntej* lawv muaj hnuv nyoog 18 xyoo. Lawv yuav tsum tau mus thov daim passport thawj zaug tshwm ntsej muag. Qhov nqi rau phau ntawv hla teb chaws yog \$165 los yog nqi rau daim npav hla teb chaws yog \$65. Nws yuav kav ntev li 10 lub xyoos.

Ib tus menyuam es muaj **16 los yog 17** xyoo yuav tsum tau kev tso cai los ntawm niam thiab txiv los yog tus neeg es saib xyuas nws mas thiaj li ua ntawv thov tau phau ntawv hla teb chaws thiab yuav tsum tau mus thov tim ntsej tim muag. Lawv yuav tsum nqa ib daim ntawv sau tso cai los ntawm ib tug niam txiv los yog tus neeg saib xyuas, thiab luam daim npav I.D. ntawm niam thiab txiv, thiab tus menyuam ntawd daim npav I.D. nqa mus ntawm qhov chaw ua phau ntawv hla teb chaws. LOS YOG leej niam leej txiv los yog tus neeg es saib xyuas nrog menyuam thiab mam li muab lawv daim npav I.D. qhia rau. Qhov nqi rau ib phau ntawv hla teb chaws yog \$165.
