Conciliation Court yog dab tsi?

Chav hais plaub Conciliation Court mas tej thaum hu ua “People’s Court” Pej xeem lub Tsev Hais Plaub” los yog “Small Claims Court” Tsev Hais Plaub Nqi Me. Yog hais cov plaub yooj yim uas muaj kev sij cav nyom txog li ntawm \$20,000. Yog rooj plaub caum nuj nqi, xws li cov credit card, tsis pub tshaj \$4,000. Koj tsis tas muaj kws lij choj. Txhua lub nroog muaj lub tsev hais plaub Conciliation Court no.

Hom plaub twg thiaj li yuav mus hais hauv Conciliation Court?

Koj muaj feem thov kom them cov nyiaj tiv koj rov qab, lossis muab cov khoom tsis yog koj li rov qab.

Nov yog tej plaub uas piv txwv:

- Koj mus yuav ib lub tsheb qub, es tus neeg muag tsheb dag hais tias lub tsheb zoo li cas.
 - Koj ua hauj lwm tag lawv tsis kam them koj.
 - Koj tus neeg koom tsev nrog koj nyob tiv koj nyiaj los yog tau koj cov khoom.
 - Muaj neeg lees tias lawv tau koj ib qhov khoom (yuav tsum tsis muaj nqis tshaj \$20,000).
 - Tus neeg nyob ntawm koj ua puas tsuaj koj cov khoom vaj khoom tsev.
 - Koj tus tswv tsev tsis thim koj cov nyiaj cas tsev rov qab.

Cov plaub dabtsi mus hais tsis tau hauv Conciliation Court Chav Hais Plaub Pejxeem Sib Foob?

Nws muaj ib co plaub uas koj coj mus hais tsis tau hauv conciliation court. Yog hais tias koj muaj yam plaub li no, koj yuav tau mus hauv tsev hais district court, txawm yog hais tias tus nqi koj foob qis dua \$20,000.



Nov yog ib co pivtxwv:

- Koj thov tsis tau nyiaj them “mob nkeeg thiab raug txomnyem” lossis puas siab ntsws
- Koj foob tsis tau txhaum kev kho mob
- Koj foob tsis tau ib tus neeg vim nws ntxub ntxuag koj
- Koj foob tsis tau ib tug neeg vim kev thum npe phem, dag puas npe, lossis hais lus thum koj lub koob lub npe tsis zoo
- Koj coj tsis tau cov plaub hais txog daim ntawv tswv cuab tsev/av lossis kev tsis sib haum txog ciam teb av

- Koj thov tsis tau kom ua raws li daim ntawv cog lus. Qhov no txhais tau hais tias koj thov tsis tau kom lub tsev hais plaub yuam ib tug neeg ua ib yam li qhov lawv cog lus hauv daim ntawv, xws li kho/ua dabtsi.

Nws muaj lwm hom plaub uas koj koj mus hais tsis tau hauv conciliation court. Yog hais tias koj tsis paub tseeb seb koj rooj plaub puas hais tau hauv conciliation court, nrog ib tug kws lichoij tham.

Puas tsim nyog kuv ua ntawv foob hauv Conciliation Court?

- Sim sib kho qhov teeb meem nrog tus neeg sab tov ua ntej. Xa daim ntawv qhia hais tias tus neeg sab tov tiv koj dab tsi thiab vim li cas ho tiv. Sau hnuv tim rau daim ntawv. Ceev ib daim qauv. Koj kuj hais tias koj yuav ua ntawv foob. Thov kom teb koj tsis pub dhau 2 lub lim tiam. Txhob hais tej yam chim siab los yog phem – tsuas hais qhov muaj tseeb xwb. Nco ntsoov hais tias cov lus koj sau kuj yuav muaj feem tus neeg kws txiav txim yuav nyeem.
- Kuj xav txog “kev sib khom-mediation.” Kev siv khom-Mediation yog txoj kev los daws cov teeb meem tawm hauv tsev hais plaub. Cov kws tswj kev Sib Khom-Mediators yeej muaj kev kawm txog cov kev sib cav nyom thiab pab cov pej xeem uas muaj feem los sib khom kom muaj kev sib haum xeeb. Lawv yuav pab sau daim ntawv sib khom haum kom ib tus neeg twg yuav tau ua dab tsi los thiaj li meej. Tus neeg sab tov uas muaj kev cav nyom yuav tsum pom zoo mus sib khom-mediation. Koj kuj thov hauv koj tsab ntawv seb nws puas kam mus sim txoj kev sib khom-mediation.

- Yog koj muaj ntau tshaj ib rooj plaub, mus nrog ib tus kws lij choj tham ua ntej koj ua ntawv foob. Tej zaum koj yuav foob tsis ntau los ntawm ib qhov teeb meem tshwm sim tib luj sij hawm.

Piv txwv – koj ua tsheb sib nraus, es koj ua ntawv foob hauv Conciliation Court rau qhov kev puas tsuaj rau lub tsheb. Yog foob txog lub tsheb lawm, tej zaum koj yuav plam txoj kev los foob lwm rooj plaub rau txoj kev mob nkeeg los ntawm txoj kev ua tsheb sib nraus.

Kuv yuav ua ntawv foob li cas?

Nws muaj 2 txog kev rau koj mus ua ntaub ntawv foob ib rooj plaub twg.

1. **Nws muaj ib daim ntawv tshiab [Guide and File program](#)** uas cia koj tsim thiab sau cov ntaub ntawv koj toobkas rau conciliation court “chav hais plaub pej xeem sib foob.” Mus rau www.mncourts.gov, nias “Get Forms,” nias ‘Conciliation/Small Claims Court.’ Txhua yam koj xa tau thiab xa paub yog ib feem ntawm lub khooskas.

2. **Muab/rub cov ntawv coj los ua koj tus kheej**

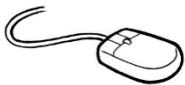
- Ua ntawv foob hauv lub Conciliation Court hauv lub zej zog uas tus neeg koj foob nyob. Yog foob lub lag luam, foob lawv ntawm lub nroog uas lawv muaj lub hoob kas.



Yog koj foob koj tus tswv tsev rau qhov nyiaj cas tsev, teeb meem kho tsev, xauv tawm, los yog xauj lub tsev tsis pub nyob lawm, koj kuj ua ntawv foob hauv lub nroog uas lub tsev nyob **los yog** tus tswv tsev nyob.

- Koj lub nroog lub tsev hais plaub muaj cov ntawv uas koj yuav tsum tau. Yog daim ntawv hu “Statement of Claim and Summons.” (*lus Askiv xwb*)

Yog koj xav tau lub tsev hais plaub cov kev qhia nrog rau cov ntaub ntawv, los yog koj xav tau daim ntawv Pov thawj Xa Mus “Affidavit of Service,” nias qhov “Filing a Conciliation Court Claim” [PACKET] pob ntawv nyob rau daim ntawv no.

Xa Ntaub Ntawv Mus Rau Txhua Tus Neeg Foob

Thaum ua cov ntaub ntawv tas lawm, cov thawj coj ua haujlwm tom tsev hais plaub mam xa ib tsab ntawv hu uas “Summons” thiab hnuv mus hais plaub tuaj rau koj. Txhua tus neeg raug foob yuav tau txais tsab ntawv “Summons” thiab ib daim ntawv qhia cov lub foob hu uas “Statement of Claim.”

Ua li no kom lawv thiab li paub hais tias vim li cas koj foob lawv thiab yuav mus hais plaub thaum twg.

Yuav xav tsab ntawv foob li cas mus rau ib tug neeg raug foob yog nyob ntawm tus nqi koj foob thiab lawv nyob qhov twg.

Yog hais tias tus nqi koj foob yog \$2,500 lossis tsawg dua, tus neeg raug foob nyob hauv Minnesota, THIAB

- **Yog tus neeg raug foob qhov chaw nyob nyob hauv lub nroog koj foob nws**, ces tus thawj ua haujlwm hauv tsev hais plaub yuav xa tsab ntawv ua “first class” mus.
- **Yog tus neeg koj foob qhov chaw nyob TSIS NYOB hauv lub nroog koj foob nws**, tiamsis nyob hauv Minnesota, TEJ ZAUM tus thawj ua haujlwm hauv tsev hais plaub yuav xav tsab ntawv “first class” mus rau txhua tus raug foob. Qhov no nyob ntawm hom rooj plaub. Yog hais tias tus thawj ua haujlwm hauv tsev hais plaub tsis xa tsab ntawv mus rau cov neeg raug foob hauv koj rooj plaub, ces koj yuav tsum tau xa tsab ntawv “certified” mus rau txhua tus neeg raug foob.

Thaum ntawd yuav tau nqa qhov povthawj qhia hais tias xa mus txog lawm mus rau tus thawj ua haujlwm hauv tsev hais plaub tsis pub dhau 60 hnuv thaum tus kws txiav txim plaub ua tsab ntawv “Summons” tuaj hais plaub. Kom muaj povthawj hais tias xa txog lawm, sau daim ntawv [Conciliation Court Affidavit of Service form](#) kom tiav tom qab xa tas mus rau txhua tus neeg raug foob. Sau ntxiv ib daim ntawv Conciliation Court Affidavit of Service mus rau tus neeg raug foob.

Yog hais tias koj tsis paub xa tsab ntawv mus rau ib tug neeg raug foob, tej zaum koj yuav tau mus nrhiav kev pab ntawm ib qhov chaw lijchoj.

Yog hais tias koj foob nyiaj ntau dua \$2,500, thiab tus neeg raug foob nyob hauv Minnesota

Yog hais tias tus nqi foob nyiaj ntau dua \$2,500, ces koj yuav tsum tau xa tsab ntawv ua “certified” mus rau txhua tus neeg raug foob. Thaum ntawd yuav tau nqa qhov povthawj qhia hais tias xa mus txog lawm mus rau tus thawj ua haujlwm hauv tsev hais plaub tsis pub dhau 60 hnub thaum tus kws txiav txim plaub ua tsab ntawv “Summons” tuaj hais plaub.

Kom muaj povthawj hais tias xa txog lawm, sau daim ntawv [Conciliation Court Affidavit of Service form](#) kom tiav tom qab xa tas mus rau txhua tus neeg raug foob. Sau ntxiv ib daim ntawv Conciliation Court Affidavit of Service mus rau tus neeg raug foob.

Yog hais tias koj tsis paub xa tsab ntawv mus rau ib tug neeg raug foob, tej zaum koj yuav tau mus nrhiav kev pab ntawm ib qhov chaw lijchoj.

Yog hais tias tus neeg raug foob qhov chaw nyob tsis nyob hauv Minnesota

Thaum ntawd feem ntau yuav tsum tau nqa tsab ntawv “Summons” mus cev kiag rau tus neeg raug foob. Tej zaum koj yuav tau thov kom ib tug tub ceevxwm “sheriff” lossis ib tug neeg ua haujlwm xa ntawv nqa daim “Summons” mus, txawm yog hais tias qhov nyiaj foob tsawg dua \$2,500. Kom muaj povthawj hais tias xa txog lawm, koj yuav tsum tau sau ib daim ntawv txawv [Conciliation Court Affidavit of Service form](#) tom qab xa tas mus rau txhua tus neeg raug foob.

Nws muaj ib hom neeg raug foob uas muaj kev cai tshwj xeeb xa ntawv mus, xws li cov tuam txhab isalas nyob txawv xeev thiab tej hom tuam txhab loj. Yog hais tias koj tsis paub xa tsab ntawv mus rau ib tug neeg raug foob, tej zaum koj yuav tau mus nrhiav tswv yim ntawm ib qhov chaw lijchoj.

Qhov lawv rov foob (counterclaim) yog dab tsi?

Tus neeg koj foob (tus neeg raug foob) muaj feem tig los foob koj tau, hais tias koj tiv **lawv** nyiaj. Lub tsev hais plaub yuav mloog rooj plaub tig rov los foob koj tib lub sij hawm thaum mloog koj roob plaub.

Kev tham sib haum xeeb (settlement) yog dab tsi?

Muaj ntau rooj plaub kuj muaj kev sib haum xeeb yam sim khom haum ua ntej mus hauv tsev hais plaub. Koj kuj muaj kev sib haum tim tsev hais plaub ua ntej koj rooj plaub mus hais muaj yeej muaj swb. Xav txog txoj kev ncaj ncees thiab sab laj nrog rau tog sab tov. Txawm hais tias koj yeej hauv tsev hais plaub, tej zaum koj yuav muaj teeb meem mus caum cov nyiaj. Ces, qhov kev sib haum yuav tau nyiaj tam sim kuj yog ib qhov ntse tshaj.



Sau cov kev sij haum xeeb tseg! Ob tog yuav tsum kos npe thiab sau hnub tim. **Nqa txoj kev sib haum mus rau hauv tsev hais plaub hnub uas teem mus sib hais**, thiab kom lub tsev hais plaub muab teev ua ntaub ntawv tseg. Qhov no yuav pab tau koj yog lwm hnub tsis muaj kev haum xeeb.

Kuv yuav npaj li cas mus tim tsev hais plaub?

- Sau txhua yam uas koj yuav xav hais.
- Nrog cov tim khawv tham thiab thov kom lawv tuaj ntawm rooj plaub. Teev lus hauv tsev hais plaub mas zoo dua sau ntawv teev lus tuaj. Thiab, cov kws txiav txim yuav tsis txais cov ntawv sau teev lus tuaj. Yog tias tus tim khawv tseem ceeb tsis kam tuaj, nug tus neeg tuav ntaub ntawv tim tsev hais plaub kom tau daim ntawv “subpoena.” Daim ntawv subpoena yog daim ntawv yuam kom tuaj ua tim hauv tsev hais plaub los yog nqa cov pov thawj tuaj tim tsev hais plaub.
- Yog tias tus neeg raug foob muaj cov ntaub ntawv los yog cov pov thawj uas lawv tsis kam muab rau koj, nug lub tus neeg tuav ntaub ntawv hauv tsev hais plaub txog daim ntawv subpoena kom tau cov pov thawj.
- Xyaum piav qhov tshwm sim rau koj ib tus phooj ywg ib yam li koj nyob tim tsev hais plaub.
- Nqa tag nrho koj cov pov thawj mus rau tim tsev hais plaub: cov duab, cov ntawv, cov ntawv pov thawj yuav khoom, cov ntawv kuaj seb raug nqi li cas, cov ntawv cog lus xauj tsev. Koj yuav tau muaj pov thawj kom txaus thiab nthuav koj cov pov thawj txog cov nyiaj uas tsim nyog los them koj. Nws yog ib qho tsim yim zoo uas koj nqa 3 daim ntawv luam rau txhua daim povthawj. 1 daim rau koj, 1 daim rau tus neeg raug foob, thiab 1 daim rau tus Kws Txiav Txim Plaub.
- Mus saib lawv hais plaub hauv Conciliation Court ua ntej koj rooj kom thiaj paub lawv hais li cas.
- Thaum nyob hais rooj plaub, coj kom tus **heev** rau tus kws txiav txim thiab tus neeg raug foob. **Txhob cuam tshuam** thaum lwm tus neeg tham. Tsis txhob chim rau cov lus uas tus neeg foob hais. **Koj rooj plaub mas nyob ntawm koj tus cwj pwm!**



Thaum twg kuv mam tau txais lub tsev hais plaub txoj kev txiav txim?

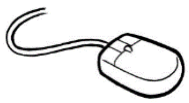
Lub tsev hais plaub feem ntau tsis txiav txim thaum hnuv tuaj hais rooj plaub. Lawv kuj yuav pab koj thiab tus neeg raug foob kom muaj kev sib hawm thaum tuaj hais plaub. Yog tias haum, lub tsev hais plaub mam txiav txim koj rooj plaub tom qab thiab xa daim ntawv txiav txim tuaj rau koj.

Cov lus kom ua li hais nyob hauv txoj kev txiav txim yuav siv tsis tau yuav tsum tos tom qab 20 hnuv tau txais daim ntawv qhia. Tus neeg tuav ntaub ntawv tim tsev hais plaub yuav qhia koj txog hnuv tim nyob hauv daim ntawv tuaj qhia. Qhov 20-hnuv no hu ua "stay period." Qhov no muab sij hawm rau ob tog los tawm tsam hais dua.

Yog kuv yeej ne kuv yuav mus sau cov nqi li cas?

Lub tsev hais plaub Conciliation YUAV TSIS mus sau nqi txiav txim yeej rau koj. Koj muaj feem yeej tau koj rooj plaub hauv conciliation court, tiamsis nws tsis txhais tau hais tias tog tod yuav cia li them nyiaj rau koj. Yog hais tias lawv tsis them koj lossis lawv tsis nrog koj tham kom pom zoo hais tias lawv yuav them koj li cas, nws muaj tej yam rau koj los sim ua kom muab tau qhov nyiaj. Nws yuav siv sij hawm yuav tau ua siab ntev! Nco ntsoov, koj muaj 20 hnuv tom qab qhov kev txiav txim xa tuaj txog koj mas mus pib qhov txheej txheem sau nuj nqi.

Daim ntawv tawm tsam rov hais dua yuav tsum xa mus rau tus neeg tuav ntaub ntawv tim tsev hais plaub thiab xa mus rau tog sab tov tsis pub dhau 20 hnuv tom qab hnuv lub tsev hais plaub xa los nqa txoj kev txiav txim tuaj ntawm rooj plaub pej xee sib foob tuaj. Yog tias koj tsis xa ua daim ntawv tawm tsam tuaj kom ncav sij hawm yuav muab rooj plaub tso tseg mus.



Yog tias koj tsis yeej hauv tsev hais plaub district court, koj yuav tau them \$50 mus npog cov nuj nqi tsim los ntawm tog sab tov. Yog tias koj yeej, lawv yuav tau them qhov nqi \$50 rau koj.

Yog xav paub tshaj no ntxiv txog lub tsev hais plaub Conciliation Court mus saib Attorney General lub vas sab ntawm <https://www.ag.state.mn.us/Consumer/Handbooks/ConCourt/Default.asp>,

Cov ntawv Qhia Tseeb yog qhia kom paub txoj kevcai xwb TSIS yog muab txwv yim txog txoj kevcai. Mus ntsib ib tug kws lij choj rau tswv yim. Tsis txhob siv daim ntawv qhia tseeb yog tias nws qub tshaj ib xyoos lawm. Nug peb txog cov hloov tshiab, daim ntawv qhia txog cov ntawv qhia tseeb, lossis lwm hom ntawv.
